**ANNOUNCEMENT  
REGARDING STUDENT RETURNING TO CAMPUS  
FOR FACE-TO-FACE TEACHING AND LEARNING (TnL) IN  
THE SECOND SEMESTER 2020/2021 SESSION**

In line with the statement by the Ministry of Higher Education (MOHE) dated 31 January 2021 regarding the physical return of students to campus for studying in a hybrid manner, UUM management has discussed and careful consideration related to TnL issues for the Second Semester 2020/2021 (A202) has been made.

In this regard, UUM has agreed that TnL for the Second Semester of Session 2020/2021 (A202) will continue in a hybrid manner, that is, a combination of face-to-face and online classes. A small number of courses that require practical sessions, and use of laboratories and special equipment will be allowed to be conducted face-to-face with the involvement of a very minimal number of students. Emphasis on strict compliance with Standard Operating Procedure (SOP), as outlined by the Ministry of Health (MOH) to prevent the spread of Covid-19 on campus, will be given priority.

The list of courses offered as face-to-face classes for Semester A202 is as presented in the **Appendix**. Students who register for these courses may return to campus to attend face-to-face classes. Student admission registration must go through the registration process as set by the Department of Student Affairs and Alumni. Please refer to the notice of **STUDENTS RETURNING TO UUM CAMPUS PHYSICALLY FOR SEMESTER A202** which was issued by the Department of Student Affairs and Alumni on 2 February 2021.

The Department of Academic Affairs will issue information from time to time through official media (email, Facebook, and Department of Academic Affairs' website) for reference by all students. This notice is subject to changes in instructions and circulars issued by the Government and the University from time to time.
